





Motives of the cross-border co-operation

- Removal of border as a separating line
- Overcoming prejudices and aversions, dissolving historical heritage
- Termination of peripheral conditions and isolation
- Increasing economic growth and living standards
- Facilitating fast integration into the EU



Basic principles of cross-border co-operation

- **Subsidiarity:** every decision has to be made on the most optimal level
- Additionality: EU funds do not replace, they add to national expenditure
- Concentration: focusing sources and tools
- Partnership: close co-operation of actors
- Programming: long term, complex development programs



Working methods of cross-border co-operation

- Strategy oriented operation, not only case by case programs
- Complex co-operation, through many kinds of connecting channels
- Partners' relationship vertically and horizontally
- Decisions and implementation of joint actions always on the basis of procedures in effect



Main fields of cross-border cooperation

- Economic development
- Infrastructure development
- Protection of environment and nature
- Tourism
- Cultural relationships
- Education
- Civil relationships
- Public safety, catastrophe prevention
- Social co-operation



Specific objectives of DKMT

- Basic objective: establishing a strong system of relationships relying on jointly developed infrastructure, information and knowledge base, helping the development of innovation, to improve the living conditions of the inhabitants of the DKMT Euroregion
- Turning DKMT into a model region, a mediator of values between the EU and the Balkans
- Increasing abilities of the region to put up sources



SWOT analysis of DKMT Strengths

- Valuable natural resources
- Multicultural traditions
- Varied and attractive landscapes, divergent cultural heritage – excellent tourism related endowments
- Developed R+D and innovation potential
- Joint strategic planning
- Availability of international airport



SWOT analysis of DKMT Strengths

- Important European corridors intersect the Euroregion
- There are three internationally acknowledged higher educational centres in the region that have been working together
- Working media relationships and cultural co-operations
- Developing international and EU system of relationships



SWOT analysis of DKMT Weaknesses

- Existence / possibility of EU membership
- Differences in EU sources, tendering possibilities, support systems. The EU harmonisation of economy is significantly divergent
- Shortage of capital, lack of interest on behalf of investors, low level of own sources, relative poverty in all three areas



SWOT analysis of DKMT Weaknesses

- Weak transport connections within the region, outdated infrastructure
- Border crossing stations with insufficient capacity
- Underdevelopment of tourism infrastructure, lack of integrated tourism information
- Lack of Euroregional tourism marketing
- Polluted surface and ground waters



SWOT analysis of DKMT Weaknesses

- Lack of the system of tools necessary for the management of cross-border environmental pollutions
- Insufficiency of the institutional system of cross-border regional and local level cooperation
- Lack of innovation disseminating aspects
- Negative demographic tendencies



SWOT analysis of DKMT Opportunities

- Improvement of relationships, stabilizing circumstances on the Balkans
- The region can function as a Southeast European gate with the enlargement of the EU
- Availability of EU support for cross-border cooperation
- The university centres of the region are capable of catalysing European level development



SWOT analysis of DKMT Opportunities

- The Euroregion is able to integrate the connection of regional development and the knowledge base
- The development of Trans-European Networks intersecting the region enables the reconstruction of transport networks torn apart, and thus connecting the region to the circulation of the European economy
- Strengthening the international logistical role



SWOT analysis of DKMT

- Changes of the political situation might negatively affect co-operation
- Relatively high environmental risk of serious natural disasters
- The slowness of infrastructural developments restricts co-operational possibilities
- Failure to close up economy and especially agriculture may cause social problems



- Shortfall caused by the insufficient financing of R&D and the sector of higher education
- The different dates of EU accession may cause tensions
- The Schengen border control may hinder co-operation
- The tourism related marketing activity is not realised because of the lack of resources



Priorities of the strategic program of the DKMT

- 1. Increasing social cohesion in the Euroregion
- 2. Improving the main road system, encouraging and harmonisation of interstate development measures
- 3. Strengthening economic relationships and the gate role within the region
- 4. Coordinated and sustainable development of the environment and nature

The project helps the multilingual communication of the DKMT, it motivates the euroregional, integration and innovation related efforts of cross-border regions, and it provides assistance for the stabilisation and EU integration processes of the region with special tools.



Overall objectives

- Eliminating the peripheral nature of the cross-border region
- Increasing the level of euroregional information supply and awareness in the border region
- Supporting the formation of euroregional co-operations and the principle of subsidiarity
- Activating the economic life, economic relationships of partner countries, strengthening regional business relationships



Direct objective

- The **direct objective** of the project is the establishment of an information centre, which helps the operation of euroregional relationships with news agency activities, multilingual multimedia press service
- The establishment of the DKMT Euroregional Information Centre and the Serbian contact office, operation of a news agency, on-line information services
- Building of euroregional relationships and networks
- Developing the own professional press network of the border region
- Delivery of knowledge, experiences, accentuated management of information regarding the European integration
- Strengthening coherence in everyday life



Target group

- Media of the DKMT Euroregion: local and regional newspapers, radios, televisions
- First of all county newspapers published in a large number of copies and local radios, several dailies and weeklies published in a large number of copies in the Vojvodina
- Media websites, which means an alternative media on the one hand and further readers on the other hand
- Professional organisations, chambers of commerce, educational and cultural organisations, civil organisations of the cross-border region

Overall objectives

- Improving the level of tourism related services, development of tourism infrastructure
- Enlivening national and foreign tourism, decreasing seasonal characteristics
- Increasing the competetiveness of the region in the field of tourism, connecting to the circulation of international tourism – increasing the number of visitors and the income generated by tourism



Direct objectives

- Development of thematic route packages:
 - 1. Health tourism (wellness and thermal) route
 - 2. Folklore route
 - 3. Route of secession
 - 4. Route of industrial establishments and monuments
- Planning and implementation of the system of information boards
- Co-ordination of tourism related services and service providers along thematic routes, establishing co-operations
- A wide range promotion of developed tourism packages, preparation of thematic publications
- Creating the touristic image of the Euroregion, strengthening identity



Target group

- Tourism related professional organisation of the border region (stage organisations, professional associations gathering enterprises)
- Local governments of the settlements along thematic routes
- The owners or operators of establishments incorporated in the thematic routes, enterprises serving tourism
- Settlements with unique attractions that can be incorporated in the thematic routes, participating from tourist traffic to a smaller extent so far

Main objective

To give possibility to the 50 invited experts and professionals

- to establish co-operations,
- to build relationships

through the organisation of a several day workshop, and laying the foundation for the cross-border risk analysis and management.

The subjects of the workshops cover studying the sources of danger affecting the DKMT Euroregion to the greatest extents:

- flood,
- Hazardous materials and their transport,
- epidemics, and within it bird-flu.



Direct results of the project:

- The development of cross-border and international relationships,
- Elaboration of recommendations as regards cross-border activities to be implemented jointly,
- Increasing the level of information received by citizens on the longer run,
- Improving the preparation of organisations participating in civil defence.



Projects under evaluation

1. Health insurance without borders (INTERREG IIIA)

- 2. Setting up an action group for the joint management of flood challenges (INTERREG IIIA)
- Increasing the capacity of local governments in the DKMT Euroregion with the tools of information technology (Norwegian Financing Mechanism)



Problems encountered on the basis of DKMT experiences

- Lack of development sources
- Lack of competences necessary for implementation
- The proportion of EU funds allocated for crossborder programs is small
- There is no sufficient experience in the field of direct EU funds from Brussels
- In the case of national co-financing the whole of the DKMT Euroregion cannot be beneficiary
- From a Hungarian call for proposal the Romanian or the Vojvodina part of the DKMT cannot receive support



Problems encountered on the basis of DKMT experiences

- The calls for proposals are not synchronised and they are often deficient
- It is hard to gain direct information about EU sources with Brussels based management
- Pre-financing problems
- VAT financing problems
- There is no separate chapter about euroregional co-operations in the NDP, there is no state support
